

- To do and cause to do all such lawful activities as are in accordance with the spirit and principles of the objects of the trust or which are conducive to the attainment and pursuit of the aims and objects of the trust.

Each of the above objects shall be independent of the other and one of the above objects involve the carrying on of any business, trade or any activity for profits.

5. TRUST FUNDS:-

The funds of trust shall be raised through:-

- a) Membership fee, Public donation, Grant-in-aid from the different department of the Govt. State/National/Corporate sector. Others Donor agency from different country/company/corporate sector/income tax payee & training and consultancy & the NGO shall be registered with FCRA, Income Tax Act, and 35AC. The funds shall be utilized for the specific purpose for which it is raised. All the funds of the trust shall be deposited in the nearby bank/ post office in the joint signature of Managing Trustee-Cum-Chairman & Director-Cum-Treasurer. Especially the account opened in any nationalize bank in the **name** of trust and money should be withdrawn by the joint signature of Managing Trustee-Cum-Chairman&Director-Cum-Treasurer. All the Grant-in-Aid/ Donation/ Membership/ Contribution should be deposited in the bank & withdrawn by the Managing Trustee-Cum-Chairman & Director-Cum-Treasurer of the society.
- b) In pursuance of the said desires and for carrying out those desires into practice, the trustees shall hold on the present trust fund of **Rs.10,000/-** and all other funds, money,

property, estate which may be received by them hereafter secure to the trust, either by way of donations, contributions, endowments, subscriptions, income, interest, dividend or otherwise, and all investments representing the same (all of which shall hereinafter be called the Trust Fund), and subject to the provisions and powers of the trustees hereinafter declared and expressed.

- c) The trustees shall stand to be possessed to the said trust fund upon trust to receive the interest, dividends and other incomes thereof and in the first place to reimburse themselves or pay the discharge all the costs, charges expenses incurred in or about or incidental to the administration or execution of the trust, or powers of these presents, and also all out goings, dues and other amounts payable in respect thereof and cost of meeting ordinary repairs to any immovable property, if for the time being, subject to the rules and trusts of these presents and subject there to upon trust to apply the residue of the said in most dividend and other income hereinafter called the said income, and at their discretion to apply the whole or any parts of the corpus of the trust fund for public charitable purpose in India, as per, in accordance with, and in fulfillment of the objectives of the trust enumerated above or such other purpose as the trustee may deem fit, provided that the said income as well as the corpus of the trust fund shall be applied only towards charitable purpose or for the furtherance and fulfillment of the objectives expressed in these presents, and any accumulation of income shall also be made and deemed to have been made for application to such charitable purposes in India as aforesaid, in accordance with

- d) Without prejudice to the generality of the foregoing objects and purposes, but subject as afore said, it is declared that the trust shall each year apply the residue of the said income of the trust fund and may at their discretion at any time and from the time to time apply also the corpus of the trust fund in or towards any one or more of the objectives expressed in these presents, as the trustee may in here absolute discretion think proper.
- e) The trustee shall, where any aid is proposed to be given for charitable purpose to any institutions, association, society, organization, body or trust, ascertain that the objects of such institution, association, society, body or trust are in line with those of the trust, and if so satisfied, may give donation to such of them for being utilized only for such objects. The surplus and unapplied portion of the said income, if any, arising in any one or more years shall be accumulated and /or invested in accordance with the provisions of the Income Tax Act-1961, as may be in force from time to time.
- f) The trust funds shall be deposited in a scheduled or Nationalized Bank or banks or banks sponsored by nationalized as may be decided upon by the board of trustee from time to time. The board of trustee in council shall authorize the opening of such account or accounts by a resolution as provided for in (6) & (7) below.
- g) The Bank accounts by the following trustees:

6. **POWERS AND AUTHORITIES OF THE TRUSTEES:-**

- a) To constitute themselves into a Board of Trustees consisting of all the trustees herein appointed and take all decisions concerning the efficient planning, running, management & administration of all the programs, activities and projects of the trust and the properties, funds, securities, investments and other incomes comprising the trust fund and to vest in it all the powers and authorities.
- b) The Chairman will act as the managing trustee to administer the trusts contained and expressed in this deed of trust, on behalf the Board of Trustees, and Treasurer will assist the managing trustees in holding the trust fund.
- c) To meet in council, deliberate and decide by a simple majority upon any matter concerning the administration of the affairs and funds of the trust, subjects to provisions made herein.

- h) To purchase, construct or hire or take on lease or on mortgage any immovable and movable property for all or any of the objectives of the trust at such price, cost, rent or amount, and on such terms and conditions, and for such periods, and with or without option for renewal as the trustee in council may think fit.
- i) To collect contributions, donations either in kind or in cash or endowments in such a manner as May, from time to time, be determined by the board of trustees to agreement the trust funds.
